



ILLINOIS 2002 COCA-COLA

YOUTH BOWLING CHAMPIONSHIPS

ZONE RULES and FORMAT

1. This tournament is sanctioned by the Young American Bowling Alliance and shall be governed by the rules of the YABA. The tournament sanction number is 56.
2. **Participation** in the Zone competition is a one-time entry. Any individual who attempts to bowl twice in the Zone competition will be disqualified.

Advancers out of the league competition must remain in the division they qualified in all subsequent competition. In the event a bowler qualifies in more than one league in the same division, the bowler must advance from the league in which the highest series was bowled. For identical qualifying scores, the bowler will advance from the league where the first score was bowled. An individual advancing from league in more than one division must choose which division they wish to enter for the Zone competition.

If a bowler advances out of league competition in more than one state/province/zone, the bowler must declare one state/province/zone to continue competing before the next competition level. Participation in any level of competition past the league competition in more than one state/province/zone will result in automatic disqualification.

If an advancing bowler to the first zone decides he/she wants to change divisions before bowling in the first Zone, their entry will be dropped, advancing the next bowler from the league competition. The bowler may then bowl in league qualifying during the second qualifying window in the different division (scratch/handicap).

If an individual qualified but cannot bowl in the Zone competition, replacements will be eligible based on order of finish in previous competition.

****Bowlers must show MEMBERSHIP CARD when checking in for this tournament.**

3. **LEAGUE COMPETITION** for the State of Illinois will take place on the following dates:

NOVEMBER 3 thru 16, 2001	(1 st qualifying window)
JANUARY 5 thru 18, 2002	(2 nd qualifying window)

High school girls may choose to qualify in the first league qualifying window and bowl their zone in February/March. They may only bowl once in Zone tournament.

4. **ADVANCEMENT RATIO:** The advancement ratio from **league** competition to **zone** competition is at least **1 for every 5** entries per division, per league, or major fraction thereof, including last place ties. The base number for each division in league level is the number of league members that would have participated in that division. In all cases at least two persons per division shall advance. The advancement ratio shall be applied uniformly to all eligible divisions.
5. **ZONE COMPETITION:** Zone competition will take place at a bowling center chosen by the Illinois State Coca-Cola Committee, in the State of Illinois, on the following dates (or dates set by the Zone Director and State Director):

FIRST ZONE:	JANUARY 5/6 and/or JANUARY 12/13, 2002
SECOND ZONE:	FEBRUARY 23/24 and/or MARCH 2/3, 2002

If needed, the STATE DIRECTOR may grant changes in the qualifying dates to individual bowling centers, if dates for zone tournament can be met. ****Please note the National guideline: YABA and Coca-Cola USA have developed a multi-year contract and a provision that mandates that bowling centers serving Coca-Cola products should be chosen as the Zone Finals venue.*

6. **ENTRY CLOSING DATES:** The entry closing dates for the Zone tournaments are as follows:

FIRST ZONE: DECEMBER 3, 2001

SECOND ZONE: FEBRUARY 4, 2002

League coaches must have the completed signed entries, worksheets and money to their Zone Director by the date listed for the respective tournament. Bowlers cannot bowl in the Zone Tournament without the entry and fees being remitted to the Zone Director.

7. **DIVISIONS:** Competition shall be conducted in six (6) divisions (based on age as of 08/01/2001)

DIVISION A	Boys' Ages 11 & Under
DIVISION B	Girls' Ages 11 & Under
DIVISION C	Girls' Handicap - Ages 12 & Above
DIVISION D	Girls' Scratch - Ages 12 & Above
DIVISION E	Boys' Handicap – Ages 12 & Above
DIVISION F	Boys' Scratch – Ages 12 & Above

NOTE: The upper limit of 21 years of age to compete in the Coca-Cola has been eliminated. All members (example: YABA mentally challenged bowlers over the age of 21) are able to compete in all levels of the Coca-Cola Youth Bowling Championships.

8. **FORMAT:** Divisions A and B (**Ages 11 and Under**) will bowl three (3) games. Total pinfall for three (3) games plus handicap will determine winners in each division.

Divisions C, D, E, & F (**Ages 12 and Above**) will bowl four (4) games, changing lanes after two (2) games. Total pinfall for four (4) games plus handicap (where applicable) will determine winners in each division.

9. **ENTRY FEE:** Entry fee for all divisions is \$11.00, plus lineage to be determined by Zone Director.

The awards fee and zone and state scholarship fees will be returned 100% to the bowlers.

10. **ZONE AVERAGE:** Bowlers shall use their highest current average in any league, with a minimum of nine (9) games, as of the following dates:

FIRST ZONE: As of **NOVEMBER 18, 2001**

SECOND ZONE: As of **JANUARY 20, 2002**

Averages must be verified with a copy of the league standing sheet with the advancing bowler names being highlighted. If a bowler does not have nine games minimum, they must present a standing sheet as required.

11. **DRESS CODE:** All bowlers must wear suitable attire. **Zone Directors will have the final say on Zone Tournament dress code.**

What NOT to Wear!!

- No sweats, short-shorts, mini-skirts or spandex clothing
- No clothing depicting sex, smoking, or drinking
- No hats/caps
- No denim, parachute material, carpenter pants, cargo pants

Things OK to Wear:

- T-shirt with bowling center name or a sponsor shirt
- Shirts with a “fold down” collar
- Dress Slacks
- Girls may wear dress shorts, skorts, or skirts

Dress Code at the State Finals will be strictly enforced. Coaches are asked to review the dress code for Zone and State Finals with bowlers.

12. If no replacement has been made, any bowler arriving late shall begin play and the score shall count beginning with the frame then bowled. Frames missed shall be credited with a zero. A bowler not present to bowl when it is his/her turn will be credited with a zero for that frame.
13. Competitors shall be allowed five (5) minutes of practice on their starting pair. No practice will be allowed when moving lanes. Extreme exceptions shall be determined by the tournament director and any committee members present.
14. **SUBSTITUTIONS:** No substitutes will be permitted once athletes have started tournament play; however, replacements may be used for bowlers not present 30 minutes prior to squad time as stated in Rule #2. Bowlers unable to bowl in the first Zone must notify the Zone Director at least 48 hours in advance so a replacement can be called. Failure to do so will disqualify said bowler from advancing to the second Zone (February/March) tournament. Only emergencies (with documentation) would nullify this rule. All schedule changes are made at the discretion of the Zone Director.
15. Handicap shall be 90% of the difference between the bowler’s average and 200.
16. Symbolic awards will be given as follows: First, Second and Third place medallions in each division. Pins will be given to all Zone participants.
17. Zone Scholarships will be given as follows: One (1) out of ten (10) bowlers in each division will be awarded scholarships based on the number of entrants per the Zone Director’s ranking. Scholarships will be held in the S.M.A.R.T. Program, ATTN: Ed Gocha, 5301 S. 76th, Greendale, WI 53129, telephone number: 414-421-4700.

18. No smoking or consumption of alcoholic beverages shall be allowed by guests or athletes on the concourse or in the settee area, only in designated areas.
19. Only bowlers and tournament officials shall be permitted in the settee area.
20. Claims for errors in scoring or general playing rules must be made to the Tournament Director no later than the start of the next block or 30 minutes after the completion of competition. Questionable errors shall be decided upon by the Tournament Director. All other protests must be submitted in writing to the Tournament Director within 48 hours or before awards are given out. Each protest under this rule must be specific in itself.
21. Advancement ratio from Zone competition to the State Finals is at least 1 for every 7 entries per division, or major fraction thereof, including last place ties. In all cases at least 2 people per division shall advance to State Finals. The advancement ratio shall be applied uniformly to all eligible divisions.
